Must be current or not expired for more than 2 years. u The New York State Department of Motor Vehicles (DMV) will not issue a learner permit, driver license or non-driver ID card for the first time, or if you have a document that has been expired for more than 2 years, until you do the following. We encourage you to get a REAL ID or Enhanced Driver License (EDL) now. New Yorkers who wish to fly within the U.S. using only their New York State issued license or non-driver ID will need a REAL ID or Enhanced Driver License or non-driver ID after the October 1, federal deadline. The New York DMV will send a renewal notice days before license expiration. It's important you renew as-soon-as-possible to avoid a lapse in your driving privileges. The renewal opens 1-year before or 2-years after the expiration date.. Those under 21 can renew their license at least days prior to turning 21, marking their license with "Under 21". A REAL ID is available at DMV offices, and it costs the same as a standard New York license, permit or non-driver ID. But an enhanced driver's license costs \$30 more. It has another function: You.
