The Real ID Act begins October 1, , only state-issued driver licenses and identification cards that are fully compliant with the REAL ID Act will be accepted for official federal government purposes such as boarding domestic flights. Texas drivers should replace their driver's license if it is lost, stolen or damaged. Drivers caught driving without a license, even if it is stolen, can be subject to fines and penalties on their driving record. Drivers whose licenses are stolen must file a police report. The Texas Department of Public Services (DPS) may

change a driver's license number if it was stolen. Anyone who has a driver's license issued by another U.S. state may drive in Texas for only 90 days on that license.
