Additionally, if your parents or grandparents were born in or have lived in Pakistan, you will be ineligible to apply for the e-Visa, even if you are a passport-holder of one of the pre-approved. It is an electronic visa that allows foreign visitors to visit India for tourism, sight-seeing, business, medical visit or conferences. The visa form also requires the applicant to glue a photo taken according to the visa photograph specifications and requirements..
